The purpose of this inspection was to conduct a Complaint inspection.

This inspection was conducted on the following date(s): May 28, 29, June 2, 3, 4, 2020 (on-site) and June 5, 8 and 9, 2020 (off-site).

A log related to an applicant's application for admission to the home being refused by the licensee.

During the course of the inspection, the inspector(s) spoke with the Central East Local Health Integration Network (CE LHIN) Placement Co-ordinator, the Director of Care (DOC) and the Resident Care Co-ordinator (RCC) and Behavioural Support Ontario/Registered Practical Nurse (BSO/RPN).

The inspector reviewed the applicant's application for admission, and the rejection letter for admission.

# WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 44. Authorization for admission to a home

Specifically failed to comply with the following:

s. 44. (7) The appropriate placement co-ordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 43 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,

(a) the home lacks the physical facilities necessary to meet the applicant's care requirements; 2007, c. 8, s. 44. (7).

(b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or 2007, c. 8, s. 44. (7).

(c) circumstances exist which are provided for in the regulations as being a ground for withholding approval. 2007, c. 8, s. 44. (7).

## Findings/Faits saillants :

1. The licensee has failed to comply with s. 44 (7)(a) of the Long-Term Care Homes Act (LTCHA) whereby the licensee refused the application of applicant #005 for reasons other than provided for in the LTCHA.

The Ministry of Health, Central Intake Assessment and Triage Team (CIATT) received a written complaint from the Placement Co-ordinator of the Central East (CE) Local Health Integration Network (LHIN), regarding applicant #005.

Inspector #601 reviewed the written complaint, which indicated that applicant #005 had submitted their most recent application for admission to the home on a specified date. The Director of Care (DOC) wrote a rejection letter to applicant #005 on a specified date. The rejection letter indicated the home lacked the physical facilities necessary to meet the applicant's care requirements.

During a telephone interview, the Placement Co-ordinator of the Central East (CE) Local Health Integration Network (LHIN) indicated to Inspector #601 that applicant #005 had received a rejection letter on a specified date. According to the Placement Co-ordinator, the DOC had originally accepted applicant #005 and the applicant had been placed on the LTCH waiting list. They further indicated that applicant #005 did not have the specified reason for rejection or require the specified accommodation, as stated in the rejection letter.

Inspector #601 reviewed the home's letter for the specified date, addressed to applicant #005, signed by the DOC of the LTCH. The letter stated the home lacked the physical facilities necessary to meet the applicant's care requirements and details for withholding approval for applicant #005's admission to the LTCH were specified in the letter.

During an interview, the Resident Care Coordinator (RCC) and the DOC indicated to Inspector #601 that they had reviewed applicant #005's application to the LTCH and the letter was written to withhold applicant #005's admission to the home on a specified date. The DOC and the RCC both specified the reasons for withholding the application and believed the resident required a specified accommodation.

Inspector #601 reviewed applicant #005's application to the LTCH including a specified assessment completed by the Placement Coordinator on a specified date. There was no documentation indicating the applicant had the specified reason or that they required a specified accommodation. The documented evidence provided by the licensee did not support how the home lacked the physical facilities to meet the applicant's care requirements, or how the licensee did not have the necessary resources to meet the applicant's care requirements.

The licensee has failed to comply with s. 44 (7)(a) of the LTCHA, whereby the licensee withheld the approval of applicant #005's application to the LTCH for reasons other than provided for in the LTCHA. [s. 44. (7) (a)]
