The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): October 15-18, 23-26, 2018.

The following intakes were included in this inspection:

Log #008668-18 (CIS #2718-000020-18), Log #008680-18 (CIS #2718-000021-18), Log #009725-18 (CIS #2718-000027-18), Log #010685-18 (CIS #2718-000028-18), Log #025319-18 (CIS #2718-000039-18) and Log #026994-18 (CIS #2718-000042-18)-incidents of resident to resident abuse, Log #009488-18 (CIS #2718-000026-18) and Log #009497-18 (CIS #2718-000025-18)-incidents of alleged staff to resident abuse.

During the course of the inspection, the inspector(s) spoke with residents, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), the Resident Care Coordinator (RCC), the Director of Care and the Administrator.

During the course of the inspection, the inspector conducted a walking tour of the resident care areas, reviewed resident health care records, and made resident observations.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure care was provided to resident #001 as outlined in the plan of care.

On an identified date, PSW #108 requested help with resident #001 who had been toileted. When PSW #112 entered the bathroom to assist, resident #001 was found on the toilet in an awkward position and was unable to stand.

Resident #001's plan of care was reviewed and at the time of this incident, indicated the resident required a sit to stand lift and two staff for all transfers.

The Administrator was interviewed in regards to this incident and indicated PSW #107 had failed to utilize the sit to stand lift and the two staff that were required for all of resident #001's transfers. The Administrator indicated that PSW #112 had been able to confirm that there had been no sit to stand lift in the room at the time of the incident and that they had to retrieve one in order to get the resident safely off of the toilet. The resident did not sustain any injuries as a result of the incident. [s. 6. (7)]

Additional Required Actions:

**VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure resident #001 is transferred as specified in the
plan of care, to be implemented voluntarily.**
