s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

Staff neglected to provide care and services related to the health, safety and well being of a resident as evidenced by a pattern of inaction which jeopardized the resident's safety. The resident sustained numerous falls and a significant weight loss. [LTCH, 2007, S.O. 2007, c.8 S.19(1)]
