**The purpose of this inspection was to conduct a Resident Quality Inspection inspection.**

**This inspection was conducted on the following date(s): June 23, 26, 27, 28 and 29, 2017**

**Critical Incident Log #008819-17, related to a resident fall and transfer to hospital, was inspected concurrently.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care (DOC), the Environmental Service Supervisor, the Food and Nutrition Manager, Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), Housekeeping staff, Recreations staff, the president of Residents' Council, residents and family members.**

**A tour of the home was carried out, an observation of medication administration, meal services, staff to resident and resident to resident interactions was made. A review was also completed of residents' health records, the Licensee's internal investigations and relevant policies and procedures related to falls, minimizing of restraints as well as skin and wound care.**
