The purpose of this inspection was to conduct a Complaint inspection.

This complaint inspection is related to an alleged abuse and included information from a critical incident report under Log 026707-16.

During the course of the inspection, the inspector(s) spoke with the home's Associate Executive Director, Director of Care, Associate Director of Care, a Clinical Manager, Registered nursing staff, Personal Support Workers and residents.

In addition the Inspector reviewed resident health care records including plans of care and behavioural monitoring records, along with the licensee's investigation and actions in relation to the alleged abuse and observed the identified residents on the unit. The inspector observed resident interaction and the resident's environment.
