Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): December 21- 24, 2021 and January 10-12, 2022.

During the course of the inspection, the inspector made observation of care and services, reviewed relevant clinical health records, and interviewed staff and residents.

During this inspection the following critical incidents were inspected:

Log #015115-21; Critical Incident (CI) # 2420-000027-21 related to an altercation between two residents.

Log #014519-21; CI #2420-000026-21 and log #019811-21; CI #2420-000034-21 related to residents sexual responsive behaviours.

Log #019197-21; CI # 2420-000033-21 related to a fall.
