**The purpose of this inspection was to conduct a Follow up inspection.**

**This inspection was conducted on the following date(s): January 16-17, 2014**

**During the course of the inspection, the inspector(s) spoke with the Executive Director, Assistant Executive Director, Director of Care, Staff Development Coordinator, Clinical Manager, a Registered Nurse, several Registered Practical Nurses, several Personal Support Workers and Residents.**

**During the course of the inspection, the inspector(s) reviewed the health care records of three residents, reviewed policy related to Contenance Care, Medical Directive for Medication, Compliance Plan from the home, important messaging to staff notices, Complex Alert Documentation Reports and observations on resident care units.**

**s. 131. (2) The licensee shall ensure that drugs are administered to residents in accordance with the directions for use specified by the prescriber. O. Reg. 79/10, s. 131 (2).**

1. The licensee has failed to comply with LTCHA 2007, c. 8, r.131 (2) in that the licensee did not ensure that drugs are administered to residents in accordance with the directions for use specified by the prescriber.

Resident #002 has a history of constipation. Resident #003 has a diagnosis of Diverticular disease of the intestine and a history of constipation. Both residents had the following physician's orders:

- Bowel Protocol 1- no BM x 3 days - Milk of Magnesia 30mL (PRN)
- Bowel Protocol 2- no BM x 4 days - Dulcolax Suppository 10MG (PRN)
- Bowel Protocol 3 - Fleet Enema x1 (PRN)

On specified dates in December 2013, and January 2014 resident #003 did not receive the prescribed medication and treatment for bowel management as indicated in the physician's orders.

On another specified date in December 2013 both Resident #002 and Resident #003 did not receive the prescribed medication for bowel management as indicated in the physician's orders.

Interview with the Director of Care confirmed the intent of the physician's orders for these residents related to bowel management.

Interviews with both staff #204 and staff #208 confirmed they had a common understanding with the Director of Care of the intent of the physician's orders for bowel management.

As such, the licensee did not ensure that drugs for bowel management are administered to residents in accordance with the physician's orders. [s. 131. (2)]

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that drugs related to bowel management are administered to residents in accordance with the directions for use specified by the prescriber, to be implemented voluntarily.***
