WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 241. Trust accounts

Specifically failed to comply with the following:

s. 241. (4) No licensee shall,

(a) hold more than \$5,000 in a trust account for any resident at any time; O. Reg. 79/10, s. 241 (4).

(b) commingle resident funds held in trust with any other funds held by the licensee; or O. Reg. 79/10, s. 241 (4).

(c) charge a resident, or a person acting on behalf of a resident, a transaction fee for withdrawals, deposits, or anything else related to money held in trust. O. Reg. 79/10, s. 241 (4).

Findings/Faits saillants :

1. The licensee has failed to ensure that no licensee hold more than \$5,000 in a trust account for any resident at any time.

A review of resident #004's statements revealed that the resident had more than \$5000 in his/her trust account for six months in 2015-2016.

A review of resident #005's statements revealed that the resident had more than \$5000 in his/her account for eight months in 2015-2016.

A review of the home's policy #AS-0201-01, entitled "Payments from Trust Accounts", reviewed January 5, 2012, indicated "the regulation prohibit a long-term care home from holding more than \$5000.00 in a trust account for any resident at any time".

Interview with Support Assistance Accounts revealed that the home had some trust accounts go over \$5000 from time to time.

Interview with Assistant Administrator confirmed that the home is not allowed to keep more than \$5000 in a trust account for any residents at any time. [s. 241. (4) (a)]
