WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records Specifically failed to comply with the following subsections:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,

(a) is in compliance with and is implemented in accordance with applicable requirements under the Act: and

(b) is complied with. O. Reg. 79/10, s. 8 (1).

Findings/Faits saillants:

1. The Home has developed policies and procedures for staff to follow in the implementation of the Infection Prevention and Control Program. Five staff members did not follow the Home's policy on gloving when they were conducting the following tasks:

On January 18, 2012, a staff member walked down the hallway wearing gloves, walked up to a resident in a wheelchair and pushed her into her room, a staff member was pushing blood pressure monitoring equipment down the hall wearing gloves, a staff member walked down the hallway wearing gloves and a staff member wore gloves while pushing 2 stools from the dining room into the lounge area.

On January 19, 2012 a staff member wore gloves while pushing a resident out of her room in a wheel chair. This same staff member carried garbage to the cart then reentered a room without washing his hands. (sect. 8 (1) (b))
