Authorization for admission to a home

s. 51 (7) The appropriate placement co-ordinator shall give the licensee of each selected home copies of the assessments and information that were required to have been taken into account, under subsection 50 (6), and the licensee shall review the assessments and information and shall approve the applicant's admission to the home unless,

(b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or

The licensee failed to ensure that the decline of applicant's admission approval was in accordance with circumstances permitted in the legislation

Rationale and Summary:

The home declined applicant's approval for admission, citing a lack of nursing expertise to manage the care needs associated with responsive behaviours.

The Staff acknowledged that the home has two secured units, with trained Behavioral Support Ontario (BSO) staff members and external support from Geriatric Mental Health Outreach Team.
