The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the *Long-Term Care Homes Act, 2007* (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with LTCHA, 2007, c. 8, s. 3 (1). Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:

1. Every resident has the right to be treated with courtesy and respect and in a way that fully recognizes the resident's individuality and respects the resident's dignity.

Findings:

1. On the night shift of October 4, 2011, a resident reported to be pushed back in a lazy boy by a Registered Practical Nurse and the leg rest of the chair was brusquely lowered.
2. On the night shift of October 4, 2011, the resident stated to be treated roughly by a Registered
