The purpose of this inspection was to conduct a Complaint inspection.

This inspection is in regards to complaint log # 021351-20 related resident care and services, fall prevention, pain management, nutrition and hydration services as well as to visitor restrictions as a result of the pandemic.

During the course of the inspection, the inspector(s) spoke with the Administrator, Program Managers for Personal Care and Resident Care, an attending Physician, the Infection Control Lead, several Registered Nurses (RNs), several Registered Practical Nurses (RPNs), several Personal Support Workers (PSWs), a Registered Dietitian (RD), a Food Service Manager and Food Service Supervisors, Physiotherapist and Physiotherapy Aide, Housekeeping Staff, Ottawa Public Health representatives and to several residents.

During the course of the inspection, the Inspector(s) reviewed resident health care records, reviewed medication administration records, observed and reviewed infection control practices and housekeeping practices, observed provision of resident meal services, reviewed Ontario Chief Medical Officer of Health Directives #3, reviewed City of Ottawa communication regarding visitor restrictions as a result of the pandemic.
