The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): February 12 and 13, 2014

During the course of the inspection, the inspector(s) spoke with the Administrator, one of the two Managers of Resident Care Services (MRCS), 1 Registered Nurse (RN), 1 Registered Practical Nurse (RPN), several Personal Support Workers (PSWs) and dietary aides.

During the course of the inspection, the inspector(s) reviewed a resident's health record and plan of care, examined a tub room and the equipment in the tub room, reviewed staff orientation and training records, reviewed policies and procedures and reviewed the home's Orientation program.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee failed to ensure that the care set out in the plan of care is provided to the resident as specified in the plan LTCHA 2007, c. 8, s. 6 (7)

On a day in December 2013, after bathing a resident in the tub and drying and applying cream to the resident's body, a PSW attempted to apply an incontinence brief while the resident was still seated on the tub chair. The unsecured resident slid out of the tub chair and fell to the floor.

The current plan of care clearly identified that the incontinence brief was to be changed or applied while the resident was in bed, following previous fall incidents.

The plan of care identified numerous interventions of care where the resident requires the assistance of 2 persons for repositioning, for transferring with mechanical lift, for personal hygiene, for bathing, for toileting. [s. 6. (7)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance in ensuring that the care set out in the plan of care is
provided to the resident as specified in the plan, to be implemented voluntarily.***
