The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): May 19th - 22nd, 2015

During the course of the inspection, the inspector(s) spoke with the Administrator, the Director of Care, the Assistant Director of Care, a Personal Support Worker and an ArjoHuntleigh Field Service Technician. Following the on-site inspection, the inspector communicated via email and by phone with representatives of the college "La Cite", including the coordinator for the Personal Support Worker (PSW) training program, a teacher with the PSW training program, and a clinical placement supervisor with the PSW training program.

The inspector reviewed details of a reported accident that occurred during the transfer of a resident with a mechanical lift, the inspector observed the lift that was involved in the accident, the inspector reviewed the lift's operating and product care instructions manual as well as the preventive maintenance schedule document, the inspector reviewed the home's documented daily inspection and preventive maintenance records for the lift, and, the inspector reviewed training records for the staff person involved in the accident.
