The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): October 31 and November 1, 2016

This follow-up inspection of the compliance order #001, inspection # 2016_381592_0010 related to s.8(1) whereby the licensee did not follow their policies regarding Medication Administration, Management of Narcotic and Controlled Drugs and Self-Administration of Medication.

During the course of the inspection, the inspector(s) spoke with residents, resident families, Personal Support Workers (PSW), Registered Practical Nurses (RPN), Registered Nurses (RN), the home's Educator, the Assistant Director of Care (ADOC), the Director of Care (DOC) and the Executive Director.

At the time of the inspection, the inspector reviewed resident health care files and observed aspects of resident care. The inspector observed medication administration passes, medication cart systems and narcotic boxes. The inspector reviewed the accompanied narcotic control books for each home area. The inspector reviewed the following Licensee policy and procedures: Administration de Medicaments in place as of August 31, 2016, Gestion des Stupefiants et des Medicaments Controles last revised August 2012, Auto-Administration de Medicaments last revised August 2012, and the home's pharmacy provider policy and procedure Elimination de Medicaments-Timbres Transdermiques last revised July 2014. The Plan of correction related to this order was reviewed including the employee education, training and auditing records.
