The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): September 30, October 1 and 2, 2019.

This inspection was completed for the following Critical Incidents:

Intake Log #018562-19, CIS #2655-000061-19, related to allegation of staff to resident abuse.

Intake Log #018078-19, CIS #2655-000057-19, related to unexpected death of a resident.

Intake Log #016671-19, CIS #2655-000051-19, related to a resident's fall.

Intake Log #016109-19, CIS #2655-000049-19, related to allegations of resident to resident abuse.

During the course of the inspection, the inspector(s) spoke with two Director of Care, four Personal Support Workers, five Registered staff and four residents.

The inspector(s) also toured the home, observed residents and care provided to them, reviewed clinical records, incident reports, investigation notes and reviewed specific policies and procedures of the home.
