1. The licensee had not ensured that any plan, policy, protocol or procedure put in place was complied with.

It was determined through the home's investigation of an incident that staff were not following the home's policy LTC-K-80 Bath Lifts, Tub Chairs and Shower Commodes related to:

- a) seatbelt use, and
- b) number of staff required during use of this equipment.

Management of the home confirmed the expectation that this policy must be followed while using mechanical lifts. [s. 8. (1) (b)]
