**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 44.
Authorization for admission to a home**

Specifically failed to comply with the following:

- s. 44. (9) If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,**
- (a) the ground or grounds on which the licensee is withholding approval; 2007, c. 8, s. 44. (9).**
 - (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care; 2007, c. 8, s. 44. (9).**
 - (c) an explanation of how the supporting facts justify the decision to withhold approval; and 2007, c. 8, s. 44. (9).**
 - (d) contact information for the Director. 2007, c. 8, s. 44. (9).**

Findings/Faits saillants :

1. Log O-0001369-14.

The licensee has failed to provide an applicant, the Director and the appropriate placement coordinator with a written notice that sets out the ground or grounds on which the licensee is withholding approval and the detailed explanation of the supporting facts as they relate to both to the home and to the applicant's condition and requirement for care and an explanation of how the supporting facts justify the decision to withhold approval.

Review of the licensee's letter withholding of approval of admission to an applicant did not give an explanation of supporting facts of why the licensee could not accommodate the condition or the care needs of the applicant. [s. 44. (9)]
