**WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 90. Maintenance services**

**Specifically failed to comply with the following:**

**s. 90. (3) The licensee shall ensure that the home's mechanical ventilation systems are functioning at all times except when the home is operating on power from an emergency generator. O. Reg. 79/10, s. 90 (3).**

**Findings/Faits saillants :**

1. The licensee has failed to ensure that procedures are developed and implemented to ensure that the mechanical ventilation systems are functioning at all times, except when the home is operating on power from an emergency generator.

The make up air system serving the older section of the home was not functioning during the inspection on February 19 and 20, 2015. Make up air grills are located on walls in the corridors in the vicinity of rooms 209/211 and 307/309.

During the afternoon on February 19, 2015, the 2nd floor corridor and lounge in the vicinity of a 2nd floor resident bedroom was malodorous. The make up air system serving the wing was not functioning. The exhaust system was identified to be operational in areas checked during the inspection.

Air quality may be negatively affected by non functional components of a mechanical ventilation system, which is a potential risk to the health, comfort and well being of residents. [s. 90. (3)]

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the make up air system in all areas of the home remains operational at all times, except when the home is operating on power from an emergency generator., to be implemented voluntarily.***
