The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): August 21, 22, 23, 24 and August 28, 2017.

Critical Incident Log # 019946-16 related to an allegation of staff to resident sexual abuse and Log # 019098-17 related to allegations of staff to resident neglect were inspected concurrently during this inspection.

During the course of the inspection, the inspector(s) spoke with Resident #001, Resident #001's Family members, Registered Nurses, Registered Practical Nurses, Personal Support Workers, Behaviour Ontario Support team member(BSO), Physician and the Administrator.

During the course of this inspection, the inspector observed staff to resident interactions during the provision of care directed towards and provided to resident #001 and resident #002. The inspector reviewed clinical documentation, health care records, the licensee investigation and complaint response documentation.
