Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (a requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA).

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 20. Policy to promote zero tolerance

Specifically failed to comply with the following:

s. 20. (1) Without in any way restricting the generality of the duty provided for in section 19, every licensee shall ensure that there is in place a written policy to promote zero tolerance of abuse and neglect of residents, and shall ensure that the policy is complied with. 2007, c. 8, s. 20 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure that staff complied with the home's policy on Zero tolerance of Abuse and Neglect.

The home's policy indicated that in case of abuse or suspected abuse, the employee having knowledge of an incident verbally reports the same to their supervisor, or charge nurse or designate immediately.

An incident was reported to the Ministry of Long-term Care (MLTC) about resident alleged abuse three days later from when the incident was reported to the staff member.

Staff verified that the incident should have reported immediately to their supervisor.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that staff complied with the home's policy on Zero tolerance of Abuse and Neglect, to be implemented voluntarily.
