The licensee has failed to ensure the following grounds were met when they refused an applicant's admission to a Long Term Care Home (LTCH), which included:

- (a) the home lacks the physical facilities necessary to meet the applicant's care requirements;
- (b) the staff of the home lack the nursing expertise necessary to meet the applicant's care requirements; or
- (c) circumstances exist which are provided for in the regulations as being a ground for withholding approval.

Rationale and Summary

A complaint was received by the Ministry of Long-Term Care (MLTC) related to an applicant's admission refusal to a LTCH.

A review of the LTCH's refusal of admission letter, documented the LTCH lacked the resources and could not safely meet the applicant's care requirements.

The applicant's Substitute Decision Maker (SDM) stated, they wished for the applicant to be admitted to a specific LTCH.

In an interview the licensee said, the Home Care and Community Support Services (HCCSS) client notes and assessments for the applicant were reviewed, and the licensee had several concerns related to the cited care requirements. When asked if the cited care requirements and additional concerns were based on current HCCSS client notes and assessments, the licensee said no. The home's decision to refuse the applicant's admission was based on the applicant's prior care requirements.

Review of (HCCSS) client notes and assessments determined the applicant was currently eligible for LTCH placement and did not document the applicant was currently expressing any of the licensee's cited care requirements or concerns.

The applicant's Nurse Practitioner (NP), said treatment and interventions had been successful, resulting in the applicant's eligibility for LTCH placement. Furthermore, the NP said they had not had any difficulties in caring for the applicant and a transitional plan to support the applicant's move to the LTCH environment was developed.

Although cited by the licensee, none of the legislated grounds or circumstances from subsection 51 (7) were actually present or substantiated, at the time the applicant applied for their authorization of

admission, for the licensee to withhold the applicant's admission.

The licensee failed to accept the applicant's application for admission, in the absence of circumstances existing which were provided for in the regulations as being a ground for withholding approval.
