The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): October 28, 31, Nov 1, 4, 2013

Five critical incidents were reviewed during this inspection.

During the course of the inspection, the inspector(s) spoke with a Registered Practical Nurse, a Registered Nurse, the Social Worker, the Assistant Director of Care, the Director of Care and the Administrator.

During the course of the inspection, the inspector(s) completed a walk through of the resident units, made resident observations, reviewed resident health care records and reviewed the home's policy on abuse and neglect.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 24. Reporting certain matters to Director**

**Specifically failed to comply with the following:**

**s. 24. (1) A person who has reasonable grounds to suspect that any of the following has occurred or may occur shall immediately report the suspicion and the information upon which it is based to the Director:**

- 1. Improper or incompetent treatment or care of a resident that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 2. Abuse of a resident by anyone or neglect of a resident by the licensee or staff that resulted in harm or a risk of harm to the resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 3. Unlawful conduct that resulted in harm or a risk of harm to a resident. 2007, c. 8, s. 24 (1), 195 (2).**
- 4. Misuse or misappropriation of a resident's money. 2007, c. 8, s. 24 (1), 195 (2).**
- 5. Misuse or misappropriation of funding provided to a licensee under this Act or the Local Health System Integration Act, 2006. 2007, c. 8, s. 24 (1), 195 (2).**

**Findings/Faits saillants :**



---

1. The licensee has failed to comply with LTCHA, 2007, s. 24 (1) whereby incidents of abuse of a resident that resulted in harm or risk of harm to a resident were not immediately reported to the Director.

On an identified date, an altercation occurred between Residents #2 and #4 and resulted in resident injury. The incident was not reported to the Director until a critical incident was submitted the following day.

On another identified date, an altercation occurred between Residents #1 and #3 and resulted in resident injury. The incident was not reported to the Director until a critical incident was submitted the following day.

During a resident health care record review, an altercation was noted to have occurred between Residents #2 and #5 on an identified date which resulted in resident injury. This incident was not reported to the Director.

On an identified date, an altercation occurred between Residents #2 and #4 and resulted in a resident injury. The incident was not reported to the Director until a critical incident was submitted four days later.

In a discussion with the Director of Care (DOC), the unreported incident was believed to be the result of a system error as the DOC had all of the related documentation except for the critical incident. In all of the above incidents, the home had appropriately notified the police, physician and Power of Attorneys in accordance with the legislated requirements. [s. 24. (1)]

***Additional Required Actions:***

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure all incidents of abuse of a resident by anyone that results in harm or a risk of harm to the resident are immediately reported to the Director, to be implemented voluntarily.***

**WN #2: The Licensee has failed to comply with O.Reg 79/10, s. 104. Licensees who report investigations under s. 23 (2) of Act**

**Specifically failed to comply with the following:**

**s. 104. (1) In making a report to the Director under subsection 23 (2) of the Act, the licensee shall include the following material in writing with respect to the alleged, suspected or witnessed incident of abuse of a resident by anyone or neglect of a resident by the licensee or staff that led to the report:**

**5. The name and title of the person making the report to the Director, the date of the report and whether an inspector has been contacted and, if so, the date of the contact and the name of the inspector. O. Reg. 79/10, s. 104 (1).**

**Findings/Faits saillants :**

1. The licensee has failed to comply with O. Reg 79/10, s. 104 (1) 5 whereby reports made to the Director in writing with respect to the alleged, suspected or witnessed incidents of abuse of a resident did not include whether an inspector had been contacted.

Five critical incidents submitted by the home were reviewed. All of the incidents reported resident to resident abuse. The reports did not include whether an inspector had been contacted and, if so, the date of the contact and the name of the inspector. [s. 104. (1) 5.]
