Term Care Homes, dated April 2022, revised September 2023 (IPAC Standard), section 10.1 states that the licensee shall ensure that the hand hygiene program includes access to hand hygiene agents, including 70-90% Alcohol-Based Hand Rub (ABHR).

On January 15, 2024, Inspector #740790 observed portable and wall mounted ABHR dispensers with expired ABHR products in the North and Georgian Wing dining rooms.

During an interview conducted on January 15, 2024, staff #107 acknowledged that the expired portable and wall mounted ABHR dispensers would have been considered expired and should have been replaced.

During an interview conducted on January 18, 2024, staff #112 acknowledged that the ABHR with expired dates should be replaced and expired ABHR product would not be as effective against viruses and other infections.

Using expired ABHR products, may increase the risk of transmission of infection agents in the home.
