The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): March 2, 3, 6, and 7, 2017.

During the course of the inspection, the inspector(s) reviewed the action plan of the home related to order served January 31, 2017, inspection #2016_251512_0016, follow up order intake # 005002-17, clinical health records, staff training records, staff schedules, home policies related to fall prevention, maintenance, housekeeping, abuse, safe and secure home, resident bill of rights and criminal reference checks; completed observations of laundry department, exit doors, receiving area, doors leading to non residential areas, provision of care, and staff to resident interactions; conducted a tour of resident care areas.
