The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

WN #1: The Licensee has failed to comply with O.Reg 79/10 s.140.

Every licensee of a long-term care home shall ensure that each medical absence, psychiatric absence, casual absence and vacation absence of a resident of the home is recorded.

Findings:

- Casual absences were not recorded on a consistent basis for the resident.
- Leave of absences were recorded when the resident left the home but are inconsistent in capturing when the resident returned.
- The home's Administrator informed the inspector that they identified a clerical error in calculation of days the resident was out of the building prior to July 1, 2010. The home has now implemented a new tracking process to record leave of absences from the home for all residents.
