During the course of the inspection, the inspector(s) spoke with the Executive Director, the Director of Care (DOC), RAI-MDS Coordinator, Activity Director, Maintenance Supervisor, Registered Nurse (RN), Registered Practical Nurses (RPN), Personal Support workers (PSW), Housekeeping Workers, Family and Resident Council Presidents, Residents and Family members.

During the inspection, the inspector (s), toured the resident home areas, observed staff to resident provision of care, infection control practices and medication administration. The inspectors reviewed residents' health records, maintenance records, applicable policies, resident and family council minutes and critical incidents.
