The purpose of this inspection was to conduct a Follow up inspection.

An inspection (2014-265526-0016) was previously conducted July 24-31, 2014. Non compliance was identified with respect to the home's maintenance, housekeeping and laundry programs, however an order requiring follow-up was issued only against the maintenance program. During this follow-up visit, the conditions laid out in the order were met.
