Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 72. Food production

Specifically failed to comply with the following:

s. 72. (2) The food production system must, at a minimum, provide for, (d) preparation of all menu items according to the planned menu; O. Reg. 79/10, s. 72 (2).

Findings/Faits saillants :

1. All menu items were not prepared according to the planned menu. On October 3, 2013 at lunch the planned menu included baked chocolate chip cookie. The baked chocolate chip cookie was not prepared for those residents receiving a puree texture diet. An identified resident requested the baked chocolate chip cookie but was offered butterscotch pudding or mixed fruit; another resident was offered vanilla pudding or mixed fruit; and another resident had no choice and was given mixed fruit. This was confirmed by Personal Support Workers.

The Nutrition Manager confirmed that the pureed baked chocolate chip cookie was not prepared according to the planned menu. [s. 72. (2) (d)]
