The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): May 20 and 21, 2015

This inspection addresses both the Espanola General Hospital, Long Term Care Unit #2932 and the ELDCAP unit #2755.

During the course of the inspection, the inspector(s) spoke with the Director of Long Term Care, Coordinator of Maintenance, Resident Care Coordinator and Registered Staff.

The inspector observed bed rails and bed systems, conducted a walk through of the home daily, completed health care record reviews, reviewed Bed Entrapment Prevention Program (Policy), Bed Rail Assessment Forms and Bed System Measurement Device Test Results Worksheets and documentation supporting corrective actions taken to ensure safety with the use of bed rails.
