The purpose of this inspection was to conduct a Follow up inspection.

This inspection was conducted on the following date(s): May 11-13, 2016.

This follow up inspection was related to compliance orders issued from inspection #2015_320612_0025 related to the collaboration of nursing staff and the Registered Dietitian in their assessments of resident(s), and the development and implementation of the resident(s) plan of care so that they are integrated, consistent with and complement each other. In addition, the licensee was to ensure that resident(s) with weight loss were assessed and treated using an interdisciplinary approach.

During the course of the inspection, the inspector(s) spoke with Registered Dietitian (RD), Personal Support Workers (PSWs), and Dietary Aides. The inspector also reviewed clinical records, nursing progress notes, and dietary communication notes, and conducted dining observations of the resident and staff to resident interactions.
