WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 3. Residents' Bill of Rights
Specifically failed to comply with the following:

s. 3. (1) Every licensee of a long-term care home shall ensure that the following rights of residents are fully respected and promoted:

4. Every resident has the right to be properly sheltered, fed, clothed, groomed and cared for in a manner consistent with his or her needs. 2007, c. 8, s. 3 (1).

Findings/Faits saillants :



1. The licensee has failed to ensure that resident #001 had the right to be properly sheltered, fed, clothed, groomed and cared for in a manner consistent with their needs.

Resident #001 was cognitively impaired and exhibited verbal and physical responsive behaviours. The resident was ordered a medication to be administered three times a day as required (PRN), in January, 2014, to manage these behaviours. Since this time, the resident's responsive behaviours which included being resistive to care, gradually became more intense and frequent.

In October, 2014, resident #001 was assessed by a team of health care professionals, including a Physician due to an increase in the resident's behaviours. The Physician had recommended that if behavioural approaches and the use of analgesics were not sufficient to manage the resident's responsive behaviours, then to trial an anti-psychotic.

In November, 2014, resident #001's health declined and the resident was transferred to hospital. In December, 2014, the resident's weight had decreased from the previous month. Due to the resident's weight loss, the resident was assessed by the Registered Dietician and identified as a high nutritional risk due to poor intake.

During this inspection, it was observed by the inspector that the resident demonstrated responsive behaviours while staff attempted to assist the resident with eating, transferring and personal hygiene care for three consecutive days.

During an interview with staff, staff indicated that the resident was combative and resistive to care. Staff also indicated that the care the resident required, including bathing, continence care and assistance with eating, could not always be provided to the resident due to these responsive behaviours.

An interview with registered staff and the Director of Care confirmed that the recommendation from the Physician to trial an anti-psychotic medication had not been followed up with when the resident continued to demonstrate responsive behaviours. Resident #001 was not cared for in a manner consistent with their needs when the care resident #001 required could not be provided due to their responsive behaviours. [s. 3. (1) 4.]

**WN #2: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure that care set out in the plan of care was provided to resident #001 as specified in the plan.

Resident #001 was reassessed by the Registered Dietician (RD) in December, 2014, due to a significant weight loss. The RD changed the resident's diet order. On December 16, and 17, 2014, it was observed by the inspector that dietary staff were referring to a diet list to direct them on the type of diet to serve to the residents.

The resident's dietary care plan had been updated with the new diet and new interventions by the RD in December, 2014. The dietary list that the Dietary Aides (DA) refer to when serving the resident's meals, had not been updated with the new diet order.

On December 16, and 17, 2014, resident #001 received the incorrect diet. It was confirmed by the DA's that they served the resident the diet according to the diet list provided, however, this list had not been updated with the new diet order.

It was confirmed by the Nutrition Manager that the diet list had not been updated to the current diet order. [s. 6. (7)]



Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that care set out in the plan of care is provided to resident #001 as specified in the plan, to be implemented voluntarily.

WN #3: The Licensee has failed to comply with O.Reg 79/10, s. 8. Policies, etc., to be followed, and records

Specifically failed to comply with the following:

s. 8. (1) Where the Act or this Regulation requires the licensee of a long-term care home to have, institute or otherwise put in place any plan, policy, protocol, procedure, strategy or system, the licensee is required to ensure that the plan, policy, protocol, procedure, strategy or system,
(a) is in compliance with and is implemented in accordance with applicable requirements under the Act; and O. Reg. 79/10, s. 8 (1).
(b) is complied with. O. Reg. 79/10, s. 8 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure that any plan, policy, protocol, procedure, strategy or system was complied with.

A) In November, 2014, resident #001's family met with the Administrator, the Director of Care (DOC) and other staff from the home to discuss care concerns. These concerns included the resident's weight loss, pain management, continence care, the lack of communication and documentation of incidents including a medication error that had occurred earlier in the year.

The home's Complaint policy, #09-04-06, in the Administration manual, states that 'verbal complaints that can be resolved within 24 hours do not require a written investigation report; however if the verbal complaint can not be resolved within 24 hours a written record of the complaint as well as the investigation and outcome will be retained by the home'.



A review of the home's 2014 Complaint Log, the Medication Incident Tracking Tool and the resident's clinical records indicated that these concerns, investigations and outcomes had not been documented. During an interview with the Administrator and the DOC, it was confirmed that they did not document these concerns or the medication error and had no records related to these resident care concerns.

B) Resident #001 was ordered a routine medication for agitation and also had an additional order to administer more doses of this medication, if required (PRN).

A review of the homes's PRN Medications policy, #11-22 in the Clinical Procedures manual states that 'In addition to all of the normal requirements in a physician order, PRN orders must also contain the reason when the order may be followed or utilized. This reason for use should also be documented on the Medication Administrator Record (MAR)'.

A review of the Physician's order and the Medication Administration Record's (MAR) for September, October, November and December, 2014, which included the order for the PRN medication did not indicate the reason for when the medication could be utilized.

The policy also stated that 'If there is a regular or routine use of PRN medications this should be flagged for the physician with the goal of converting the PRN order into a scheduled medication/treatment order'.

In addition to the resident's regularly scheduled medication, staff administered the additional PRN medication 11 times in July, 4 times in August, 2 times in September and 6 times in October until the order was changed to a routine order in October, 2014.

It was confirmed by the Director of Care that staff did not follow the PRN Medications policy. [s. 8. (1) (b)]



Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that any plan, policy, protocol, procedure, strategy or system is complied with, to be implemented voluntarily.

WN #4: The Licensee has failed to comply with O.Reg 79/10, s. 36. Every licensee of a long-term care home shall ensure that staff use safe transferring and positioning devices or techniques when assisting residents. O. Reg. 79/10, s. 36.

Findings/Faits saillants :

1. The licensee has failed to ensure that staff were using safe transferring and positioning techniques when assisting resident #001.

In December, 2014, after the lunch meal service, staff were observed by the inspector taking resident #001 out of the dining room and into the resident's room. The inspector entered the resident's room while two staff were attempting to transfer resident #001 using a mechanical lift.

It was observed that the staff had the sling around the resident, however, it was not fully supporting the resident. Staff re-adjusted the sling to secure the resident, however, the brakes had not been applied while the staff were securing and raising the resident in the lift. [s. 36.]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that staff are using safe transferring and positioning techniques when assisting residents, including resident #001, to be implemented voluntarily.



WN #5: The Licensee has failed to comply with O.Reg 79/10, s. 53. Responsive behaviours

Specifically failed to comply with the following:

s. 53. (4) The licensee shall ensure that, for each resident demonstrating responsive behaviours,

(a) the behavioural triggers for the resident are identified, where possible; O. Reg. 79/10, s. 53 (4).

(b) strategies are developed and implemented to respond to these behaviours, where possible; and O. Reg. 79/10, s. 53 (4).

(c) actions are taken to respond to the needs of the resident, including assessments, reassessments and interventions and that the resident's responses to interventions are documented. O. Reg. 79/10, s. 53 (4).

Findings/Faits saillants :



1. The licensee has failed to ensure that strategies were developed and implemented to respond to the resident demonstrating responsive behaviours.

Resident #001 had cognitive impairment and exhibited verbal and physical responsive behaviours. The resident was ordered a medication to be administered three times a day as required (PRN), in January, 2014, to manage these behaviours. Since this time, the resident's responsive behaviours which included being resistive to care, gradually became more intense and frequent.

In October, 2014, resident #001 was assessed by a team of health care professionals, including a Physician due to an increase in the resident's behaviours. The Physician had recommended that if behavioural approaches and the use of analgesics were not sufficient to manage the resident's responsive behaviours, then to trial an anti-psychotic. This recommendation had not been followed up with or implemented.

During this inspection, it was observed by the inspector that the resident demonstrated responsive behaviours while staff attempted to assist the resident with eating, transferring and personal hygiene care for three consecutive days.

During an interview with staff, staff indicated that the resident's responsive behaviours were not managed. Staff also indicated that the care the resident required, including bathing, continence care and assistance with eating, could not always be provided to the resident due to their responsive behaviours.

An interview with registered staff and the Director of Care confirmed that strategies had not been implemented when the recommendation from the Physician to trial an anti-psychotic had not been followed up with or implemented when the resident continued to demonstrate responsive behaviours. [s. 53. (4) (b)]



Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that strategies are developed and implemented to respond to residents, including resident #001 demonstrating responsive behaviours, to be implemented voluntarily.

WN #6: The Licensee has failed to comply with O.Reg 79/10, s. 135. Medication incidents and adverse drug reactions

Specifically failed to comply with the following:

s. 135. (1) Every licensee of a long-term care home shall ensure that every medication incident involving a resident and every adverse drug reaction is, (a) documented, together with a record of the immediate actions taken to assess and maintain the resident's health; and O. Reg. 79/10, s. 135 (1). (b) reported to the resident, the resident's substitute decision-maker, if any, the Director of Nursing and Personal Care, the Medical Director, the prescriber of the drug, the resident's attending physician or the registered nurse in the extended class attending the resident and the pharmacy service provider. O. Reg. 79/10, s. 135 (1).

Findings/Faits saillants :



1. The licensee has failed to ensure that every medication incident that involved a resident and every adverse drug reaction was documented, together with a record of the immediate actions taken to assess and maintain the residents' health.

In April, 2014, the Physician ordered supplements, two tablets daily for resident #001. The pharmacy that services the home, sent the resident's medication, however, a different medication was sent in the medication pouches instead of supplements.

Resident #001 was already taking this medication and due to this error, the resident was taking double the dose of this medication for several days. The resident had symptoms of diarrhea after several days of taking the additional medication. The resident then had excoriation of their skin which required treatment.

This error had been identified by registered staff and reported to the resident's Power of Attorney (POA). In May, 2014, the resident's family requested a meeting to discuss care concerns which included this medication error. A meeting was held with the Administrator and the Director of Care present. An interview with the Director of Care confirmed that she had been made aware of this medication incident.

An interview with the Administrator and the Director of Care confirmed that this meeting, and the medication incident, that involved resident #001, including immediate actions taken, should have been documented, however, no documentation had been completed.
[s. 135. (1) (a)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that every medication incident that involves a resident, including resident #001, and every adverse drug reaction is documented, together with a record of the immediate action taken to assess and maintain the resident's health, to be implemented voluntarily.
