Inspection Summary/Résumé de l'inspection

The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): April 6, 7 and 8, 2021.

The following intakes were completed during this inspection:

Log #002270-21, related to alleged staff to resident abuse.

Log #003993-21, related to a missing controlled substance.

During the course of the inspection, the inspector(s) spoke with the Administrator, Director of Care (DOC), Registered Nurses (RNs), Registered Practical Nurses (RPNs), Personal Support Workers (PSWs), a Physiotherapy assistant (PTA), a housekeeper, a laundry aide, screeners, a family member and residents.

Observations were completed for general care, dining, medication administration, narcotic and controlled substance count, Infection prevention and control (IPAC) practices including use of PPE, hand hygiene, social distancing, screening and signage. A review of relevant documents was completed, which included but was not limited to resident progress notes, plans of care, assessments and electronic Medication Administration Records (eMAR), and investigations completed by the home.
