The purpose of this inspection was to conduct a Complaint inspection.

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 19.
Duty to protect**

Specifically failed to comply with the following:

s. 19. (1) Every licensee of a long-term care home shall protect residents from abuse by anyone and shall ensure that residents are not neglected by the licensee or staff. 2007, c. 8, s. 19 (1).

Findings/Faits saillants :

1. The licensee has failed to ensure that the resident was protected from abuse by anyone in the home.

Staff found a co-resident in the resident's room, and discovered an altercation had taken place between the residents. The resident had an injury and verbalized details of the altercation. The co-resident spoke about their participation in the altercation.
