1. The licensee has failed to comply with LTCHA 2007, s. 23 (2) by failing to report to the Director the results of every investigation undertaken for an alleged incident of abuse.

An incident of abuse was reported to the Director using the Critical Incident Reporting system. The home conducted an investigation into the alleged abuse. The report to the Director did not include the results related to the home's investigation.
