1. The licensee has failed to comply with LTCHA, 2007 s. 8 (3) whereby a registered nurse was not on duty and present in the home at all times.

Extendicare Kingston is a 150 bed long term care home. During a complaint inspection, the home's registered staff schedule was reviewed with the Assistant Director of Care from July 1, 2013 to date of inspection.

The home did not have Registered Nurse (RN) coverage for the following dates/shifts:

July 1, 2, 6, 24 August 14, 26, 27 (partial evening shift coverage),

July 14, 17, 22, 23, August 3, 6, 7, 11, 13 ( full night shift coverage).

The shifts were a result of an inability to cover RN vacation time, the termination of an RN and the unexpected illness of another RN. The home has since hired three RN's and have been compliant with the requirements since August 28, 2013. [s. 8. (3)]
