**WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6.
Plan of care**

Specifically failed to comply with the following:

s. 6. (7) The licensee shall ensure that the care set out in the plan of care is provided to the resident as specified in the plan. 2007, c. 8, s. 6 (7).

Findings/Faits saillants :

1. The licensee has failed to ensure that the care set out in the plan of care was provided to the resident as specified in the plan.

An incident occurred which resulted in a resident being transferred to the hospital.

The most recent care plan indicated the resident required a medical device to be in place for safety.

Review of the clinical record and the home's internal investigation revealed that the medical device was not in place at the time of the incident.

Interviews with five staff members indicated that the medical device should have been put in place for safety reasons.

The DOC stated that the internal investigation indicated that the staff had not placed the medical device as set out in the plan of care and the home's expectation was that the care set out in the plan of care was provided to the resident. [s. 6. (7)]

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that the care set out in the plan of care is provided to the resident as specified in the plan, to be implemented voluntarily.
