 - (c) an explanation of how the supporting facts justify the decision to withhold approval; and 2007, c. 8, s. 44. (9).**
 - (d) contact information for the Director. 2007, c. 8, s. 44. (9).**

Findings/Faits saillants :

1. The licensee has failed to ensure that when withholding approval for admission, the written notice provided to applicant #001 included a detailed explanation of the supporting facts, as they related both to the home's and to the applicant's condition and requirements of care; an explanation of how the supporting facts justify the decision to withhold approval; and the contact information for the Director.

A complaint pertained to withholding approval for admission to Extendicare Peterborough for an applicant was submitted to the Director by the Central East Local Health Integration Network (LHIN). The bed refusal letter addressed to the applicant indicated that the home could not accept the admission due to the lack of nursing expertise to meet their care needs.

The LIHN placement coordinator indicated that the bed refusal letter provided insufficient details to support the home's inability to admit the applicant. The DOC acknowledged that the letter did not include a detailed explanation of the supporting facts as required, for withholding an approval for admission for the applicant as well as the contact information for the Director.
