The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): September 23, 24, 27, 28, 29 and October 5, 2021

Inspected Log #005484-21 for resident to resident abuse, Log #012112-21 for a resident fall

During the course of the inspection, the inspector(s) spoke with Resident, Director of Care (DOC), Registered Nurse (RN), Registered Practical Nurse and Personal Support Worker (PSW).

During the course of the inspection the inspector reviewed the clinical health record of the identified residents, Falls Management Program, Zero Tolerance of resident Abuse and Neglect Program. The inspector observed the staff to resident provision of care and resident mobility.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 49. Falls prevention and management

Specifically failed to comply with the following:

(2) Every licensee of a long-term care home shall ensure that when a resident has fallen, the resident is assessed and that where the condition or circumstances of the resident require, a post-fall assessment is conducted using a clinically appropriate assessment instrument that is specifically designed for falls. Findings/Faits saillants:

1. The licensee failed to ensure that when a resident has fallen, the resident was assessed and that where the condition or circumstances of the resident require, a postfall assessment was conducted using a clinically appropriate assessment instrument that is specifically designed for falls.

The licensee's Fall Management Program included a Head Injury Routine (HIR) to be completed for residents for all unwitnessed falls, hourly for four hours and every shift for 72 hours.

Resident #002 had a specified number of unwitnessed falls. Review of the clinical health record confirmed that the HIRs were not completed. RN #132 confirmed that on an identified date, HIR for the resident should have been initiated and it was not. RPN #129 confirmed that the initial set of vital signs were obtained and the remaining HIR was not completed as required. On another identified date, HIRs were not completed. On another date, HIR were obtained at the time of the fall but not completed as required. Failing to complete HIR, places the resident at increased risk for potential complications related to head injury.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance by ensuring that when a resident has fallen, the resident is assessed and that where the condition or circumstances of the resident require, a post fall assessment is conducted using a clinically appropriate assessment instrument that is specifically designed for falls, to be implemented voluntarily.
