Specifically failed to comply with the following:

s. 145. (1) A licensee of a long-term care home may discharge a resident if the licensee is informed by someone permitted to do so under subsection (2) that the resident's requirements for care have changed and that, as a result, the home cannot provide a sufficiently secure environment to ensure the safety of the resident or the safety of persons who come into contact with the resident. O. Reg. 79/10, s. 145 (1).

Findings/Faits saillants :

1. The licensee discharged the resident from the home without being informed by someone permitted to do so under subsection (2). Subsection 2 (b) in the case of a resident who is absent from the home, the resident's physician or a registered nurse in the extended class attending the resident.

On December 10, 2015, a record review of resident # 001 showed that the resident was discharged from the home related to behaviours.

On December 11, 2015, the Administrator confirmed that she did not speak with a medical physician at the hospital or a nurse in the extended class to determine if the resident was assessed and not able to return to Extendicare Port Stanley at that time. [s. 145. (1)]

Additional Required Actions:

***VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2)
the licensee is hereby requested to prepare a written plan of correction for
achieving compliance to ensure that discharging the resident from the home
without being informed by someone permitted to do so under subsection (2).
Subsection 2 (b) in the case of a resident who is absent from the home, the
resident's physician or a registered nurse in the extended class attending the
resident., to be implemented voluntarily.***
