**The purpose of this inspection was to conduct an Other inspection.**

**This inspection was conducted on the following date(s): February 16, 23, March 1, 2, 3, and 4, 2016.**

**This inspection was a follow-up to a Director's Order that was issued in response to failure to report two beds in abeyance to the Director and subsequent funding received by the home for these two beds. The Long Term Care Homes ACT and Reg's 79/10 under s. 104(3) states: If beds are unoccupied and unavailable for occupancy for 14 consecutive days or more, and the licensee did not obtain written permission from the Director for them not to be available for occupancy, the Director may, by order served on the licensee, (a) amend the license to reduce the number of beds allowed under the license by the number of unoccupied and unavailable beds; or (b) impose any conditions on the license that are provided for in the regulations. 2007, c. 8, s. 104 (3). At the time of the inspection the beds had been closed for a total of 146 days. As a result of a Director Review a Director's Order was issued by Director.**

**The Director Order has been complied with.**

**During the course of the inspection, the inspector(s) spoke with the Administrator, Registered Nursing staff, Residents, and Ministry of Health and Long Term Care Licensing Program Analyst.**

**During the course of the inspection observations of the identified rooms were completed, review of the beds in abeyance approved application form, Director's Order and contractor's work orders related to the roof repairs.**
