1. Related to Log #010761-19;

A bed challenge related to a refusal for admission to this home for a specified applicant was submitted to the Director from the Central East LHIN Placement Services.

The Long-Term Care Homes Act, 2007,c. 8, s. 44 (9). states: If the licensee withholds approval for admission, the licensee shall give to persons described in subsection (10) a written notice setting out,

- (a) the ground or grounds on which the licensee is withholding approval;
 - (b) a detailed explanation of the supporting facts, as they relate both to the home and to the applicant's condition and requirements for care;
 - (c) an explanation of how the supporting facts justify the decision to withhold approval;
- 2007, c. 8, s. 44 (9).

Review of the withholding of approval for admission letter addressed to the specified applicant, advised the applicant that the home was unable to provide the adequate and the safe level of care that the applicant required.

During separate interviews with Inspector #166, the Social Worker and the Administrator indicated the home had access to both internal and external services for the support and management of the applicant's needs and care requirements.

The licensee failed to ensure that the admission refusal letter to the applicant, provided detailed explanation of the supporting facts of how both the home and resident's condition and requirements for care justify the decision to withhold approval. [s. 44. (9)]
