The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): May 12, 13, 14, 17, 18 and 19, 2021.

The following Critical Incident System (CIS) inspections were completed:

- log 003410-21 / CIS 2485-000003-21 was related to the fall of a resident.
- log 003577-21 / CIS 2485-000004-21 was related to the fall of a resident.
- log 004370-21 / CIS 2485-000005-21 was related to an injury to a resident for which the resident was taken to a hospital and that resulted in a significant change in the resident's health condition.

During the course of the inspection, the inspector(s) spoke with Personal Support Workers, Registered Nursing Staff, Housekeepers, the Physiotherapist, the Support Services Manager, an Assistant Director of Care, the Director of Care and the Administrator.

During the course of the inspection, the inspector(s) reviewed relevant documents including residents' health care records and observed the provision of care and services to residents, dining service, housekeeping services, COVID-19 screening and other Infection Prevention and Control measures.
