## Non-compliance with: O. Reg. 246/22, s. 55 (2) (b) (i)

Skin and wound care

s. 55 (2) Every licensee of a long-term care home shall ensure that,

(b) a resident exhibiting altered skin integrity, including skin breakdown, pressure injuries, skin tears or wounds,

(i) receives a skin assessment by an authorized person described in subsection (2.1), using a clinically appropriate assessment instrument that is specifically designed for skin and wound assessment,

The licensee has failed to ensure that a resident received an assessment, using a clinically appropriate assessment instrument specifically designed for skin and wound assessment, when it was identified that a specific resident exhibited altered skin integrity on a day in the month of January 2025.

s. 55 (2) Every licensee of a long-term care home shall ensure that,
(b) a resident exhibiting altered skin integrity, including skin breakdown, pressure injuries, skin tears or wounds,

(ii) receives immediate treatment and interventions to reduce or relieve pain, promote healing, and prevent infection, as required,

The licensee has failed to ensure that a resident, who exhibited altered skin integrity, received immediate treatment and interventions to promote healing.

On a day in the month of January 2025, the specific resident was identified with altered skin integrity. Treatment for the altered skin impairment was not initiated until a day in the month of February 2025.

The licensee has failed to ensure that a resident who exhibited altered skin integrity was reassessed at least weekly.

On a day in the month of January 2025, a specific resident was identified with altered skin integrity. The home's practice is to complete a Wound Assessment - PUSH or Impaired Skin Integrity Assessment upon discovery, and at least weekly thereafter. A Wound Assessment -PUSH was not completed until two weeks after the area of impaired skin integrity was identified.
