WN #1: The Licensee has failed to comply with LTCHA, 2007 S.O. 2007, c.8, s. 6. Plan of care Specifically failed to comply with the following subsections:

- s. 6. (10) The licensee shall ensure that the resident is reassessed and the plan of care reviewed and revised at least every six months and at any other time when,
- (a) a goal in the plan is met;
- (b) the resident's care needs change or care set out in the plan is no longer necessary; or
- (c) care set out in the plan has not been effective. 2007, c. 8, s. 6 (10).

Findings/Faits saillants :

1. The licensee failed to comply with LTCHA, 2007 S.O. 2007, C.8, s. 6 (10)(b) in that the licensee did not ensure a resident was reassessed and the plan of care reviewed when the resident's dietary care needs changed. A family member visited the resident on day in April 2012 and noticed the resident was experiencing difficulties during the meal service and requested changes to the resident's plan of care.

The progress notes confirm that a request for reassessment was sent to the home's dietitian on that day however the resident was not reassessed until fifteen days later.

A registered practical nurse on the unit reported that the home's practice does allow for the registered staff to initiate a temporary change in diet until the dietitian can further assess the resident. Despite this, a registered nurse on the unit confirmed that no changes had been made to the residents diet, as per the family member's request, until the dietitian's assessment fifteen days later.
