**During the course of the inspection, the inspector(s) spoke with the home's Administrator, Director of Care, Clinical Supervisor, Physician, Registered Nursing Staff and Personal Support Workers.**

**During the course of the inspection, the inspector(s) resident health records including flow sheets, plans of care and medication administration. In addition documents related to the monitoring of responsive behaviours including Policy #09-05-01 were reviewed and a letter of discharge. The inspector also observed staff-resident interaction and resident care.**

Non-compliance with requirements under the Long-Term Care Homes Act, 2007 (LTCHA) was found. (A requirement under the LTCHA includes the requirements contained in the items listed in the definition of "requirement under this Act" in subsection 2(1) of the LTCHA.)

The following constitutes written notification of non-compliance under paragraph 1 of section 152 of the LTCHA.

**(c) clear directions to staff and others who provide direct care to the resident.**

1. The licensee failed to comply with LTCHA 2007, S.O. 2007, c.8, s.6(1)(a), whereby the licensee did not ensure that the written plan of care for each resident sets out the planned care for the resident.

A review of Resident #1's health care record indicated particulars related to the resident's sleeping pattern. The health care record further demonstrates that the resident's sleeping pattern affects several areas of care. Staff interviews and documentation indicated that the management of Resident #1's sleep patterns vary and produce various outcomes related to the resident's mood/behaviour. The written plan of care does not set out the planned care for the above affected care areas and the strategies that are implemented by staff.

Staff interviews indicate that as part of the strategies to manage Resident #1's behaviours a reward system is in place. This planned care is not set out in the current plan of care for Resident #1. [s. 6. (1) (a)]
