The purpose of this inspection was to conduct a Critical Incident System inspection.

This inspection was conducted on the following date(s): July 10, 2014

During the course of the inspection, the inspector(s) spoke with the Administrator and the Director of Care.

During the course of the inspection, the inspector(s) reviewed a Critical Incident Report initially submitted by the home to the Ministry of Health and Long Term Care on June 20th, 2014; reviewed written updates provided for family and resident information related to the roof fire of June 17th, 2014; observed areas in the home affected by the fire event, in the company of the Administrator; reviewed the home's emergency plans related to fire and evacuation; observed evacuation supplies stored at the main reception area; reviewed documentation related to the home's 2013 practice evacuation exercise; observed the laundry pick up and transport system in place as a result of the fire, which rendered the home's dryers unusable because the roof top exhaust vents were affected; observed fire response information and equipment, the "fire boxes", that are in place at each nurse station.
