Specifically failed to comply with the following subsections:

s. 74. (2) The licensee shall ensure that a registered dietitian who is a member of the staff of the home is on site at the home for a minimum of 30 minutes per resident per month to carry out clinical and nutrition care duties. O. Reg. 79/10, s. 74 (2).

## Findings/Faits saillants :

1. The licensee has not ensured that there is a registered dietitian, who is a member of the staff of the home, is on site at the home for a minimum of 30 minutes per resident per month to carry out clinical and nutrition care duties.[O.Reg.79/10, s. 74. (2)]

Inspector 151 determined through staff interviews the home presently has 10 hours of dedicated Dietitian hours per month. There were no other sources of on-site Dietitian hours at the time of the inspection.

The Home's Profile report shows that the home has 120 LTC beds plus 1 short stay bed. Calculations for the required Dietitian hours for this home is as follows:

30 minutes x 120 residents = 60 hours.

The home has a short-fall of 50 hours per month of dedicated Dietitian on-site coverage.

## Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance in ensuring that a registered dietitian, who is a member of the staff of the home, is on site at the home for a minimum of 30 minutes per resident per month to carry out clinical and nutrition care duties,, to be implemented voluntarily.
