During the course of the inspection, the inspector(s) spoke with The Quality Risk Management Coordinator for Health and Safety, Directors of Care, Nurse Consultants, the Manager of Quality and Risk, the Administrator, the Regional Manager and the Ottawa Hospital Staff.

During the course of the inspection, the inspector(s) observed the resident home areas and completed a review of relevant records, including a resident's health care record and internal staffing documents.

WN #1: The Licensee has failed to comply with O.Reg 79/10, s. 229. Infection prevention and control program

Specifically failed to comply with the following:

s. 229. (4) The licensee shall ensure that all staff participate in the implementation of the program. O. Reg. 79/10, s. 229 (4).

Findings/Faits saillants :

1. The licensee has failed to ensure that two staff members were wearing a face shield/eye protection in accordance with the infection prevention and control program.

During the inspection, two PSWs on 2 different units were observed not wearing a face shield/eye protection.

According to the DOC not wearing a face shield/eye protection was in violation of the home's infection prevention and control program.

Additional Required Actions:

VPC - pursuant to the Long-Term Care Homes Act, 2007, S.O. 2007, c.8, s.152(2) the licensee is hereby requested to prepare a written plan of correction for achieving compliance to ensure that staff wear a face shield/eye protection in accordance with the licensee's infection prevention and control program, to be implemented voluntarily.
