The purpose of this inspection was to conduct a Critical Incident System inspection.

Critical Incident Log # 004182-17 concerning alleged resident to resident abuse with transfer of one resident to hospital was inspected.

During the course of the inspection, the inspector(s) spoke with the Administrator, the Assistant Administrator, the Director of Care, the Resident Care Coordinator, Registered Staff and Personal Support Worker(s). A brief tour of pertinent resident areas was conducted; resident records were reviewed, staff interviews and resident care observations were also completed.
